

# **RULES OF PROMOTIONAL SWEEPSTAKES**

## **2022 IndyGo On-Board Survey**

NO PURCHASE NECESSARY TO ENTER OR WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. **Promotional Period:** The Promotion begins on August 15, 2022 and shall continue until September 30, 2022.
2. **Entry Deadline:** The deadline to submit sweepstakes entries for each prize drawing is 11:59 PM Eastern time at the end of the promotional period.
3. **Eligibility:** This sweepstakes is open to legal residents living and working within Marion County who are at least eighteen (18) years old at the time of entry. Employees of the Indianapolis Public Transportation Corporation (IndyGo) and other companies associated with the promotion of this sweepstakes and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. Former IndyGo employees are eligible so long as they have not been employed by, or within the employment of IndyGo for at least twelve (12) calendar months before the commencement of the sweepstake.

**IndyGo reserves the right to reject or delete any entry from any individual that does not meet the eligibility requirements or fails to comply with these rules.**

4. **Sponsor:** This sweepstakes is sponsored by IndyGo, 1501 W Washington, Indianapolis, IN 46222. The promoter is ETC Institute, Inc. ETC's address is 725 W Frontier Circle Olathe, KS 66061.
5. **Agreement of rules:** Participation in this sweepstakes constitutes the entrant's full and unconditional agreement to and acceptance of these rules and the decisions of the sponsor, which are final and binding. Winning a prize is contingent on being compliant with these rules.
6. **How to Enter:** To enter the sweepstakes, an individual must participate in the 2022 IndyGo On-Board Survey and elect to submit an entry at the conclusion of the survey, along with providing the individual's home address and answering all questions. The On-Board Survey will be administered on IndyGo routes and a paper copy of the survey will be available at the Julia M. Carson Transit Center. All entries will become the property of the sponsor and will not be returned. Submissions will be accepted for the duration of the sweepstakes.

**To avoid disqualification, only the authorized account holder of the submitted email address should use that email address to participate. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning the email address or the domain associated with the submitted email address.**

**Use of any device or method to automate entry is prohibited.**

Neither the sponsor or promoter are not responsible for any technical issues that may result in an invalid submission, including disrupted, delayed, lost, or unavailable internet connections; cell phone service and/or carrier issues; computer failures, errors, or data loss of any kind; failed, incomplete, garbled or deleted computer or network transmissions; inability to access any website or online service; any other error or malfunction, late, lost, illegible or misdirected entries; or for printing errors in any advertisement, entry form or the rules.

**7. Prizes and Odds of Winning: Three 31-Day IndyGo transit passes will be awarded.**

**The odds of being selected is dependent on the number of entries received.**

**Individuals are only eligible to win one (1) transit pass. An individual that has already won a transit pass during the promotional period will be ineligible to receive an additional prize.**

8. **Prize Drawing:** The sponsor will select three winners at the end of the promotional period. Only those entries received by 11:59 PM the final day of the promotional period before the drawing will be considered in selecting a winner.
9. The sponsor will notify the winners via email or phone after the drawing. If the potential winner cannot be contacted immediately, the sponsor will select another winner at random from the remaining non-winning, eligible entries.
10. **Winner Notification:** Winners will be notified via e-mail or phone using the information provided by the entrant. The winner and promoter will coordinate the best method to deliver the prize; either by mail or through in-person pick-up by the winner. Prior to awarding any prize, the sponsor may in its sole discretion require verification of a promotion winner's identification. Sponsor reserves the right to refuse to deliver any prize to any individual whose identification cannot be verified at the time that they are contacted, or in accordance with all federal, state, and local law. Decisions of the sponsor regarding the promotion are final.
