IndyGo Purple Line Awarded Federal Funding

IndyGo has been awarded \$80.975 million for the construction of the Purple Line Bus Rapid Transit (BRT). The funding comes from the U.S. Department of Transportation's Federal Transit Administration (FTA) Small Starts Capital Investment Grant. This contribution represents 50% of the \$162 million total cost of the Purple Line, with the remaining costs covered by a combination of local funding from the approved transit



income tax, the City of Indianapolis Department of Public Works, and other FTA and Federal Highway Administration (FHWA) funding. Click [here](#) for more details.
